**Universal School Meals and Milk at No Charge for All WCPA Enrolled Students**

(Eligibility Criteria: All WCPA enrolled students are eligible for free meals and milk)

*Effective August 9, 2022* — **Wonderful College Prep Academy Delano** (2070 Veneto Street, Delano, CA 93215) and **Wonderful College Prep Academy Lost Hills** (14848 Lamberson Avenue, Lost Hills, CA 93249) will be serving program-compliant meals and milk at no charge to enrolled students until June 9, 2023. Meals and milk are available free of charge to all Wonderful College Prep Academy students through the Community Eligibility Provision (CEP) and California Universal Meals Program. Child and Adult Care Food Program (CACFP) supper is available for students attending school in-person at either campus. The U.S. Department of Agriculture (USDA) has approved waivers for local school divisions and other federal meal program sponsors for the 2022-2023 school year. These waivers are available when meal service is limited by the COVID-19 pandemic to support access to nutritious meals and milk while taking into account continuing COVID-19 related impacts.

For students attending school in-person at a Wonderful College Prep Academy campus (Monday-Friday, except for noninstructional days):

- **Wonderful College Prep Academy (Delano) – Breakfast, Lunch, and Supper either in Harvest Hall, a classroom, or another location designated by staff**
- **Wonderful College Prep Academy (Lost Hills) – Breakfast, Lunch, and Supper either in Harvest Hall, a classroom, or another location designated by staff**

For WCPA students not attending school in-person, meals and milk will be provided at the following locations (Monday-Friday, except for noninstructional days):

- **Wonderful College Prep Academy (Delano) – Parking Lot – 10:00 am-1:00 pm**
- **Wonderful College Prep Academy (Lost Hills) – Parking Lot – 10:00am-1:00pm**

Meals and milk are available at no cost to all WCPA students. No meal program applications are needed for the school meal programs. Meals and milk are available to all WCPA students regardless of race, color, national origin, sex, age, or disability.
